### THE FOIA PROBLEM

Since 1967, the Freedom of Information Act (FOIA) has been a key cornerstone of federal government transparency. It mandates that federal agencies provide access to government records upon request - unless the information falls under one of nine statutory exemptions. Core FOIA requirements include:

- Responding to FOIA requests within 20 business days
- · Train staff on FOIA requirements
- Designate a FOIA Public Liaison
- Provide dispute-resolution options
- Track, manage, and proactively disclose records

Federal agencies must also clearly communicate how to submit requests, outline applicable fees, and withhold information only when it meets exemption criteria – after making every reasonable effort to release all non-exempt material.

Today, federal agencies face mounting challenges that hinder timely, compliant FOIA processing and impact mission performance, including:

- Growing FOIA request backlogs
- Time-intensive manual review processes and workflows
- Inefficient or incomplete records searches conducted
- Failure to segregate non-exempt material appropriately
- Inconsistent documentation and data tracking practices
- Heightened data security concerns
- Increasing overall litigation costs and attorney fees
